- I. Entry deadline **Friday, March 1, 2024.**
 - A. First entry fee is \$550.
 - B. Additional entries are \$350.
 - C. Remodeler must be a member of the Remodelers Council of Lincoln to participate in the Tour of Remodeled Homes. Should a non-member wish to participate, they must submit their application for membership in time to be approved and become a member prior to submission of contract to enter the Tour of Remodeled Homes. Participation is open to all Remodelers Council members in good standing.
- II. I agree to submit all of the following additional materials by Friday, March 1, 2024:
 - A. Information sheet about the project giving a description and a map showing the location of the entry.
 - B. Photo or drawing of the **completed** project.
- III. The project must showcase a change in shape, form or function of the residence, and not have been shown to the public before.
- IV. The purpose of the Tour of Remodeled Homes is to increase exposure of our participating members; to promote a more professional image and increase our credibility; to benefit the public by stimulating an interest in remodeling existing homes; and to showcase our quality workmanship and new products while increasing the membership of the Remodelers Council.
- V. I agree to staff the home with at least two people: one person in each of the remodeled areas and one at the main entrance to take tickets the full hours of the Tour of Remodeled Homes.
- VI. I agree not to open the entered home to the public prior to the Tour of Remodeled Homes.
- VII. I agree that the Remodelers Council and/or the Home Builders Association of Lincoln will not be held liable for any loss due to theft, vandalism or personal injury.
- VIII. This contract is null and void unless at least ten projects are entered by **March 1, 2024.**
